TOYOTA Procedure

Care must be taken when installing this accessory to ensure damage does not occur to the vehicle. The installation of this accessory should follow approved guidelines to ensure a quality installation.

These guidelines can be found in the "Accessory Installation Practices" document.

This document covers such items as:-

- Vehicle Protection (use of covers and blankets, cleaning chemicals, etc.).
- Safety (eye protection, rechecking torque procedure, etc.).
- Vehicle Disassembly/Reassembly (panel removal, part storage, etc.).
- Electrical Component Disassembly/Reassembly (battery disconnection, connector removal, etc.).

1. Installation of Cargo Net.

- (a) Open hatch, locate anchor locations on the driver's side of the vehicle (Fig 1-1.)
- (b) Cover rear bumper and rear cargo area with blankets or protective cover(s).
- (c) Attach loop at the top of the net to the vehicle hook on the vehicle as shown (Fig. 1-2).
- (d) Attach hook at the bottom of the net to the D-ring on the vehicle as shown (Fig. 1-3).





- (e) Review driver's side attachment (Fig. 1-4).
- (f) Repeat steps 1(a) through 1(d) for the passenger's side of the vehicle.
- (g) Confirm completed assembly. Make sure net handle is facing out toward the rear of the vehicle (Fig. 1-5).
