NOTE: Use the adjustment tool to verify if sealant is close to the door's edge. This must be done prior to **Door Edge Guard** installation to allow for proper fit (Fig. 3-1).





Align the adjustment tool to the edge of the door, with the angle edge positioned toward the inside of the door (Fig. 3-2).


Use the adjustment tool as a depth gage down the entire length of the door's edge. This is to verify that the sealant material is back away from the edge of the door to allow for proper Door Edge Guard installation.

Sealant Issue: To push back sealant; align the adjustment tool to the edge of the door, with the angle edge positioned toward the inside of the door (Fig. 3-3).

With the adjustment tool angle tip in contact with the sealant material, push the adjustment tool inward so that the notched section of the tool is in complete contact with the door's edge. Continue down the door's edge or sections of the door's edge that requires adjustment.




